## Emission Control Area (ECA) Surcharge Q4 2021

Dear Valued Customer,

Hamburg Süd has reviewed its Emission Control Area (ECA) surcharge, and the new tariffs will be **effective October 1<sup>st</sup>, 2021**.

The ECA tariffs have been calculated using the price difference between 0,5% Sulphur fuel oil (VLSFO) and 0,1% Sulphur fuel oil (LSMGO). The difference calculated is **77,61 USD/TON**. The details on the period used for the calculation can be found in the table below.
